5. To receive the reports from the District & County Councillors:

County Cllr Wilby – In the 1990s, Norfolk established Roadside Nature Reserves (RNRs) to protect and enhance nature next to our roads. Some of these RNRs, representing remnants of Norfolk's natural grasslands, give sanctuary to rare species like spiny restharrow, pyramidal orchid, sandy silt puffball and fragrant agrimony. Many RNRs being unchanged grasslands, feature common meadow flowers and grasses important for the well-being of bees, butterflies, and other insects. Norgate Lane is RNR 196 and a plaque will be installed on the verge to identify the length of verge that has been designated.

- 6. To receive the Clerks Report and an update on correspondence received: The clerk updated the Council on the following item:

 - The District-wide Design Code for South Norfolk and Broadland consultation due to the time scale Councillors agreed the Clerk can respond.
 - Email from a resident raising major concerns on the dangerous driving on Scole roundabout
 - Email received regarding the Parish Partnership Schemes add to the agenda for discussion in September
 - The Clerk resigned from her position as Parish Clerk, she is happy to continue as the RFO until year end (31 March 2025). It was agreed that the vacancy can be advertised in the Autumn edition of the Post Horn.

7. To receive an update on the installation of a plaque on the south side of Scole Bridge:

Trying to co-ordinate the parties required to place this plaque on the bridge is holding up the proceedings, if the plaque is installed on the land owned by the Parish Council this could happen much quicker. Cllr J Ward proposed that Cllrs Jones, Brooks, McEwen and Trevail meet to agree a suitable location and get the plaque installed, seconded Cllr D Ward and unanimously agreed.

Still trying to establish more information regarding inclusive play equipment, Cllr Jones suggested an inclusive roundabout, Cllr C Ward is to investigate further.

Prouloudic estimate is for £3,000 to repair the Biibox equipment.
