The Clerk presented the budget to the Council. Expenses will increase this year by £5,217to £37,000 the predicted income is £3,818, therefore an amount of £33,182 is to be funded by precept. Proposed Cllr Fisher, seconded Cllr L Trevail and unanimously agreed.

12. To approve and sign the precept request for 2025/26:

The Council require a precept of £33,182 . A Band D property will pay £64.31 per year Council Tax a £9.10 increase. Proposed Cllr Brooks, seconded Cllr J Ward and unanimously agreed.

 - **13.4. Diss & District Neighbourhood Plan (DDNP) (Graham Moore, Corinne Moore, DW)** A letter has been sent from the DDNP to South Norfolk Council expressing their disappointment at the Neighbourhood Plan being ignored in the recent approval of the planning application by Hopkins Homes.

13.5. Scole Nature Trails Trust Group (COB, LT, GF)

- Rough sleeper sites have been cleared.
- Fish being caught and left on the Scole Bridge to die, consider a Fishing Warden.
- Fisherman leaving magnets behind.
- A140 footpath hedge is finished.
- Wood has been cleared from Lot 2
- Churchyard to Bungay Road footpath has been cleared
- Ditches on Low Road/Norwich Road being checked daily for any excessive water potentially leading to flooding.
- Hedge on Hub Site cleared

13.6. Community Centre (PJ)

- The Parish Council grant helps the Community Centre to keep the hire rates affordable to the community.
- Play Area inspection is arranged with ROSPA
- The Football Club contributes to approx. one third of the Community Centre income.

14. To report any incidents of overflow, spillage and discharge into the river during the month:

 During the month there has been another incident of raw sewage in the ditch behind Clements Close. AWA engineers have attended site and two cameras have been used to investigate issues. Tankers have been pumping out. Cllr Fisher is keeping a video diary on wet days. AWA want to see when flowing.

Cllr Jones – Bungay Road still complaining about speeding traffic, repeater signs should be installed soon.

Cllr Fisher – Sight splay on Bridge Road/Diss Road still a problem. The hedge needs to be cut back to fence and lowered. **Clerk to write to householder and Highways asking for assistance.**

Clir Blakesley – The culvert on Norwich Road to ditch opposite Common Road Bridge needs reinstating. **Clerk to contact Highways.**

Ditch at Flowerdew Meadow full of water and blocked with leaves. Clerk to contact Saffron Housing to sort ditch to stop water flooding into the village.

Cllr Jones – Some remedial work is required at war memorial, will approach Bierton Woods for a quote.
